## School Uniforms

## Uniforms—FAQs

**At the beginning of each day students are to be checked for attendance and proper uniforms.**

### What are the uniform options?

- **Black or Khaki pants**—in a solid, single color. Pants may be pleated or flat in front, should be full length, appropriately fastened and sit appropriately at the waist. Pants may be made of cotton, canvas, corduroy, linen, polyester or twill.
- **Belts** are optional, but if worn they must be black or brown.
- **Skirts and jumpers** may be khaki or black, in a solid, single color. They must be at least mid-thigh in length.
- **Shorts and capri's** may be in khaki or black, in a solid, single color. Shorts must be at least mid-thigh in length.
- **Tops** may be white, black or red collared shirts (or gray at VHS only) in a solid, single color. Tops may be long or short sleeved. (Sleeveless collared shirts will be acceptable during warmer weather— September and June) Tops may be worn either tucked inside pants or on the outside, as long as they are appropriately sized and fitted. Clothing must be clean and not ragged, ripped, frayed or contain holes.
- **Undershirts and tank tops** may be white, black, red or gray and may only be worn under appropriately buttoned tops.
- **Cardigans and sweaters** may be white, black, red or (gray at VHS Only) in a single, solid color. All must be worn over a collared shirt.
- **Footwear** includes athletic shoes, loafers, boots, dress shoes, or other closed toed/closed heel shoes.
- Vineland Public School and school logos are permitted on all attire and are not limited in size. However, they must be red, black or white. (Grey can be worn at VHS only).

### Other Acceptable Attire:

- Appropriate VHS athletic attire may be worn at VHS only.
- Collared polo shirts purchased in the school store may be worn every day
- School and club/activity polo shirts may be worn every day for Middle & High School
- Board approved nationally recognized youth organization attire, such as Boy Scouts and Girl Scouts, will be acceptable forms of attire on the days of scheduled meetings by the organizations.
- ROTC polo shirts are acceptable attire on the days when the cadets are not in their ROTC uniform.
- Hooded sweaters or hooded sweat shirts may only be worn with school logo and hoods must be down at all time.

### Inappropriate Attire and Grooming:

- No jeans, low cut pants, low rise pants, sagging slacks or pants or jeanshorts.
- Hats, caps, bandanas, hair rollers, hair curlers, plastic hair bags, hair nets, sweat bands, skull caps, and other similar clothing or grooming items shall not be worn at school. \*\*For enforcement purposes, headwear worn as legitimate religious attire (as determined by the Board of Education) may be considered as an exception.
- Logos—NO manufacturers' logos are permitted on attire that is larger than an inch and a half in measurement. Insignia on outerwear not related to the school or to the District is permitted, including professional sports teams, and college insignia. However, any offensive or gang related outerwear is prohibited. No outerwear is to be worn in the classroom.

- Students are prohibited from wearing attire that may be considered weapons, such as chain belts, wallet chains, or other similar attire.
- All apparel must be clean and not ragged, ripped, frayed or contain holes.

Whether or not a student is dressed appropriately or properly groomed shall be left to the discretion of the principal or their designee.

Student complaints regarding appropriate attire and grooming for religious and/or philosophical reasons shall follow the pupil grievance procedures outlined in Vineland Public Schools Policy and Procedures.

### Dress Code Violations and Consequences

First Offense: Verbal Warning/Written Warning

Second Offense: 1 day Lunch/Admin Detention/  
Parent Conference

Third Offense: 2 days Lunch/Admin Detention/  
Parent Conference

Failure to attend detention may result in further disciplinary actions based on the code of conduct.

### Process for Parent/Student Financial Support

- If financial support is needed, please submit a written request to the school for assistance.
- School will confirm need for assistance. If approved a copy of the Uniform Assistance Request form will be provided to the parent. They will then take the request to the store of their choice and identify the items they would like to have the district purchase. Parent must identify the item number, size, and color for each item.
- Parent will then return form to school principal and a purchase order will be generated.
- When items arrive the school will contact parent to come in and pick up order.
